"This is an important milestone for Optimi as we look to increase our presence in the capital markets. The OTCQX Best Market is the highest market tier of OTC Markets and can enhance the Company's visibility to U.S. investors," said Bill Ciprick, Chief Executive Officer of Optimi. "We believe this is an opportunistic time for all current and future investors to support the Company during this stage of growth and commercialization and look forward to begin trading on the OTCOX."

There will be no change to Optimi's Canadian listing as the Company's common shares will continue to trade on the Canadian Securities Exchange under the symbol OPTI.

Optimi has also been granted a dealer's license under Canada's Narcotic Control Regulations governing possession, distribution, sale, laboratory analysis of and research and development of Psilocybin and Psilocin formulations. Optimi is committed to expert cultivation and quality production subject to and in accordance with the terms of all applicable laws and governing regulations to ensure safe, superior Canadian fungi production.
