# Filament Health Cultivates 70th Psychedelic Mushroom Variety And Announces Annual General Meeting

Filament also announced the successful development of standardized, pharmaceutical-grade ayahuasca extract, designed for oral administration by capsule or tablet. The drug product was manufactured using Filament's proprietary processing and standardization technology.

"We are proud to announce these milestones which are a testament to the expertise of our research and development team," said Ryan Moss, Chief Science Officer at Filament Health. "Our cultivation efforts provide a robust foundation for both our drug development platform and position as a leading provider of IP-protected botanical drug candidates."

Filament's library includes 42 varieties of Psilocybe cubensis in addition to further varieties belonging to other psilocybin-producing species. The Company's research and development team is conducting ongoing cultivation, screening, and analysis to determine the highest potency and efficacy of different cultivars, as well as optima Privacy - Terms
